Pursuant to Article 17 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council of 16 April 2014 on market abuse (Market Abuse Regulation), and repealing Directive 2003/6/EC of the European Parliament and of the Council and Commission Directives 2003/124/EC, 2003/125/EC and 2004/72/EC, as well as Article 61004/1 of Euronext Rule Book I, ANDINO INVERSIONES GLOBAL S.A. (the “**Company**”) hereby notifies the following for the information of the market

The Company communicates that Servicios Aeroportuarios Andino Global, S.L. (“**SAASA Global**”) a subsidiary of the Peruvian company Servicios Aeroportuarios Andinos, S.A. (“**SAASA**”), has won the AENA’s bid for the construction and operation of a cargo terminal for a period of 30 years at one of Europe's most important airports.

Tuesday, February 20, 2024.- SAASA Global, a subsidiary of SAASA, won Aena’s tender for the construction and operation of a new cargo terminal, located on the Ramp #7, within the Air Cargo Center at Barajas International Airport in Madrid, with an area of 10,241 m² and a maximum buildable area of 3,900 m².

"The contract that SAASA Global has won involves constructing a designated area for handling and self-handling, storage, transportation and distribution of goods and air cargo. This encompasses the preliminary project outlining the general features of the endeavor, with operational rights extending over a 30-year period," said Enrique Vargas, General Manager of SAASA Global.

The proposed warehouse design considers two main areas to organize both import and export cargo. In addition, it considers more areas to deploy complementary cargo services, dock zones, maneuvering and dolly yards, parking areas, and administrative offices.

Last December 13th, 2023, the tender received eight bids; in addition to SAASA Global, Aerospace Cargo Logistics, IAS Handling, YunExpress Spain, Cacesa, UPS España, Alaire, and Worldwide Flight Services (WFS) submitted proposals. Aena opened the economic offers a few weeks ago, announcing that SAASA Global's offer was the highest.

As a reminder, SAASA Global already operates four international airports in Mexico: Benito Juárez International Airport (AICM), Felipe Ángeles International Airport in Zumpango de Ocampo, Adolfo López Mateos International Airport in Toluca, and Manuel Crescencio Rejón International Airport in Mérida. Additionally, SAASA, the parent company that is part of the

Andino Group (ANDINO INVESTMENT HOLDING), operates at Jorge Chávez International Airport in Lima, Perú.

"SAASA Global provides services with the knowledge and expertise that we operate with in all our subsidiaries in Peru and Mexico, which has made us an integral part of the logistics chain for major airlines. This internationalization process is the result of a differentiated strategy aimed at offering quality services, covering and adapting to the logistical needs of the airline industry, guaranteeing effective, agile, and 100% secure operations," said Enrique Vargas.
