<u>Lima</u>, <u>July 8th</u>, <u>2024</u>.- Throughout June 2024, Andino Inversiones Global S.A. steadily increased its stake in AIH, a subsidiary of the Company, through multiple acquisitions on the stock market according to the following details:

- On June 5, 2024, the Company bought 5,745 shares of AIH through the stock market. As a result of this acquisition, AIG increased its participation to 67.25% of AIH's common shares.
- On June 10, 2024, the Company bought 17,829 shares through the stock market. As a result of this acquisition, AIG maintained its participation at 67.25% of AIH's common shares.
- On June 13, 2024, the Company bought 56,922 shares through the stock market. As a result of this acquisition, AIG increased its participation to 67.27% of AIH's common shares.
- On June 14, 2024, the Company bought 9,000 shares through the stock market. As a result of this acquisition, AIG maintained its participation at 67.27% of AIH's common shares.
- On June 18, 2024, the Company bought 10,000 shares through the stock market. As a result of this acquisition, AIG increased its participation to 67.28% of AIH's common shares.
- On June 19, 2024, the Company bought 23,793 shares through the stock market. As a result of this acquisition, AIG maintained its participation at 67.28% of AIH's common shares.
- On June 27, 2024, the Company bought 21,446 shares through the stock market. As a result of this acquisition, AIG increased its participation to 67.29% of AIH's common shares.
